#### 2. Research Projects for SARAO Masters and Doctoral level for the 2023 Academic Year

- a. SARAO will **only** consider Master's/Doctoral scholarship applications from students who have selected an approved 2023 SARAO postgraduate research project, and obtained a signed agreement from the relevant supervisor stating that he/she will supervise the student.
- b. All projects approved by SARAO for postgraduate research for 2023, as well as the contact details of the relevant supervisors, are available at: <u>https://www.sarao.ac.za/students/funding/</u>
- c. Prior to submitting an application for a SARAO Master's/Doctoral scholarship, students must review the list of approved postgraduate research projects for 2023, and identify a project they wish to pursue for their Master's/Doctoral degree.
- d. Once a student has identified a project, he/she must then contact the supervisor of the project to discuss the project, and determine if they (the student) have the required qualifications, skills and abilities to undertake the project.
- e. If the supervisor of the approved project agrees to supervise a student for his/her Master's/Doctoral degree, the supervisor must provide the student with a signed letter, on a university letterhead, stating that he/she has agreed to supervise the student for the relevant project. The student must upload a copy of this letter with their application, as an attachment. <u>SARAO will NOT consider an application if there is no supervision-agreement letter.</u>
- f. The student must use the details of the research project, as provided on the SARAO website, to complete the "Research Project Information Section" of the application form.
- g. Students awarded a SARAO Master's/Doctoral scholarship will have to register at the university where the supervisor of the research project is based, and the student will have to undertake his/her degree at that university.

#### Note: Supervisors are under no obligation to agree to supervise a student

#### 3. Supporting Documents to be Attached to your Application Form

Please attach the following documents, as a single PDF file in the **Attachments Section** of the application form.

- a. All university academic results, from the start of your degree until now, and where relevant for all other degrees completed to date.
- b. A copy of the motivation/biography that you provided in your application form.
- c. Copy of your South African Identity Document for South African citizens and permanent residents, or, a copy of your Passport for non-South Africans.
- d. An updated Curriculum Vitae (CV).

I. Maximum duration of a SARAO Scholarship

- a. Honours: One year, however, SARAO will provide two years funding to students who register for the NASSP Extended Honours Course
- b. Master's: Two years
- c. Doctoral: Three years
- II. SARAO will pay the international student fee due to the university, for students from Botswana, Ghana, Kenya, Madagascar, Mauritius, Mozambique, Namibia and Zambia.
- III. Travel grants are awarded annually, for the duration of the scholarship.
  - a. The student must use the travel grant for travel related to his/her research. It is compulsory for a student to travel at least once a year to a conference/workshop for research purposes (unless government restricts travel, for example in the case of Covid-19).
  - b. Travel grants, or any funds remaining from a travel grant, for a particular year, will be carried over to the following year, for the duration of the scholarship.
- IV. The equipment grant is a total amount available for the full duration of the scholarship (i.e. this is not an annual amount).
  - a. The equipment grant is available to the student to support the purchase of equipment required for his/her research.
  - b. Equipment grants, or any funds remaining from an equipment grant, will be carried over to the following year, for the duration of the scholarship.
- V. Laptop grants are available to Honours students.
- VI. SARAO will organise and pay for one return ticket, per year, for students from Botswana, Ghana, Kenya, Madagascar, Mauritius, Mozambique, Namibia and Zambia, to travel to South Africa.
- VII. SARAO will pay the repatriation fee, if required, for students from Botswana, Ghana, Kenya, Madagascar, Mauritius, Mozambique, Namibia and Zambia.
- VIII. SARAO will pay the cost of emergency medical insurance for students from Botswana, Ghana, Kenya, Madagascar, Mauritius, Mozambique, Namibia and Zambia.
- IX. Students living with a disability may apply for a grant of up to R20 000. This is the maximum amount allowed during the tenure of the scholarship. An assistive device is defined as any device, product, equipment or tool that is designed or adapted to enable persons with disabilities to participate in activities, tasks or actions including: (i) mobility aids such as wheelchairs, prostheses and crutches as well as service animals (ii) communication aids such as hearing aids, Frequency Modulation (FM) systems; (iii) sensory aids such as white canes; noise reducing headphones and coloured lenses (iv) technology aids such as computers for alternate and augmentative communication, screen readers, magnifiers, texts in audio format (Strategic Policy Framework on Disability for the PSET, 2018).
